Applicants must be willing to abide by the Miss Molalla Buckeroo rules and requirements, live within a 35 mile radius of Molalla, be willing to participate in activities throughout the year and be responsible for their own horse and transportation.

## 2010 Miss Molalla Buckeroo Rules and Requirements

The 2010 Miss Molalla Buckeroo reign begins January 1, 2010 and ends December 31, 2010. First and second runner up will be named in the event that the 2010 Miss Molalla Buckeroo cannot fulfill her 2010 reign. **Miss Molalla Buckeroo will not be named until Cowboy Winter Ball on February 12, 2010.** Items 1 – 23 are required of the Miss Molalla Buckeroo representative. Violation of the requirements may result in immediate dismissal from the Miss Molalla Buckeroo position.

1. Miss Molalla Buckeroo criteria:
  - Age must be 18 – 26 as of January 1, 2010
  - Unmarried and no children
  - Cannot be pregnant or become pregnant
  - Must live within 35 miles of Molalla, Oregon
2. Furnish your own horse and transportation for the tryout competition and your reign. Proof of vehicle insurance is required. If you will be driving a vehicle that you do not own, your name needs to be listed on the insurance policy as an insured driver.
3. Have a general knowledge and understanding of the Molalla Buckeroo Association and their 4<sup>th</sup> of July Rodeo, the sport of rodeo and the PRCA.
4. Make public appearances and presentations for the Molalla Buckeroo Association from January 1, 2010 through the coronation of 2011 Court. Appearances and presentations are determined and approved by the Court Coordinator, Court Advisor, Molalla Buckeroo Association Executive Board and / or the Court Committee. Not attending a required event will result in an unexcused absence.
5. Abide by the Court Coordinator, Court Advisor, Molalla Buckeroo Association Executive Board and / or the Court Committee's instructions.
6. Attend all meetings and activities scheduled and requested by the above parties. Molalla Buckeroo events take priority over ALL events. Rodeo Court Personnel must receive a five day notice of an event that requires attendance by the Court member(s) or the events cannot be counted as an unexcused absence.
7. Provide a five day notice to the Court Advisor or Court Coordinator if you are unable to attend a scheduled event. A schedule is given to each Court member and updated as needed. If you are unable to attend a scheduled event (without earlier notice) it may be counted as an unexcused absence. It is your responsibility to arrange to attend the event and work with your Court Advisor or Court Coordinator if you have a scheduling conflict.
8. Failure to attend meetings, events, appearances and to participate in fundraising activities may result in the following:

First unexcused absence – documented verbal warning from the Court Committee

Second unexcused absence – written warning from the Court Committee

Third unexcused absence – will result in dismissal from Court by Court Committee / Executive Committee



## 2010 Miss Molalla Buckeroo Rules and Requirements

9. If the 2010 Miss Molalla Buckeroo representative is dismissed or resigns from her reign, Molalla Buckeroo Rodeo Association and the Court Coordinator reserves the right to, at their discretion:  
Replace the 2010 Miss Molalla Buckeroo with the first runner-up of original tryouts  
Hold another tryout competition  
Appoint another Miss Molalla Buckeroo for the remainder of 2010  
Leave the position vacant
10. Circumstances warranting immediate dismissal from the 2010 Miss Molalla Buckeroo position are:  
Representative is consuming alcohol (regardless of age) when promoting Molalla Buckeroo Association, the Molalla Buckeroo Rodeo or the Miss Molalla Buckeroo position in any way.  
Representative uses illegal substances at any time during her reign. 2010 Miss Molalla Buckeroo representative may be subject to random drug / alcohol screening.  
Representative fails to model good sportsmanship at any time during the reign.  
Representative has inappropriate or incorrect information on Myspace, Facebook, personal website or any other informational source, including application.
11. You must be of good moral character and maintain a professional appearance and attitude at all times. This includes all networking websites or other informational sources. You must provide access to all informational sources at the time of application. These sources may be reviewed for appropriate content prior to accepting your application to compete at tryouts. They may be checked at random intervals during your reign.
12. Representative is required to abide by all city, state and federal laws, rules policies and procedures.
13. Representative will be provided a belt buckle at the beginning of her reign and will be provided some western attire and jewelry. Any Miss Molalla Buckeroo who completes her reign shall retain these items. Any Miss Molalla Buckeroo who does not complete her reign must return these items to the Molalla Buckeroo Association or Court Coordinator, immediately upon the date of dismissal or resignation. Failure to return these items is grounds for legal action.
14. The Molalla Buckeroo Association will provide the following items for your use during your reign:  
Crown, chaps, serapes, flower packs (silk flowers), breast collar and bridle.  
All items listed above are property of the Molalla Buckeroo Association and must be returned to the Court Coordinator ten days after the Court's last activity. Items must be returned in the condition in which they were given to you or you may be required to pay for repairs or replacement. Court members who do not complete their reign must return these items immediately upon dismissal or resignation. Failure to return these items is grounds for legal action.



## 2010 Miss Molalla Buckeroo Rules and Requirements

15. Miss Molalla Buckeroo is responsible for all expenses, including but not limited to: meals, transportation, all animal maintenance, feed and veterinary bills.
16. Miss Molalla Buckeroo must have her attire, jewelry, horse, tack, truck and horse trailer and any other required items ready at all times.
17. Horses used during your reign must be well groomed, clipped, hoofs trimmed or shod, healthy, current on all shots and worming. No stallions, pregnant mares or mares with foals at their sides will be allowed.
18. Miss Molalla Buckeroo must be neat, clean, well groomed and professional. Clothing must be appropriate for the event you are attending or hosting. Court coordinator will set clothing requirements.
19. Miss Molalla Buckeroo will be punctual at the scheduled appearances and events and the representative shall not attend any functions promoting the Molalla Buckeroo Association without a chaperone or without prior approval of the Court Coordinator, Court Advisor or Court Committee.
20. At all rodeo grand entry appearances Miss Molalla Buckeroo will be required to check in at least one hour before performance time with a typed Miss Molalla Buckeroo and Rodeo announcement. The representative will be warmed up and prepared for their run-in. At all parade appearances, Miss Molalla Buckeroo will be required to check in with parade entry staff at least one hour prior to the judging of the parade or the time stated by the parade committee on the entry form.
21. Miss Molalla Buckeroo expenditures require the prior approval of the Court Committee. Expenditure request must contain specific information regarding items, cost and purpose. Items purchased without prior approval may be returned or purchased at your own expense.
22. All printed material, sponsor request letters, flyers or any other written or website material regarding Miss Molalla Buckeroo must be preapproved by the Court Committee.
23. Excess funds raised during 2010 reign of Miss Molalla Buckeroo are not for personal use and will be carried over for future Molalla Buckeroo Association use.

Participation as the Miss Molalla Buckeroo is an honor, privilege and responsibility. You must represent the Molalla Buckeroo Association and their events in a positive manner, with enthusiasm and professionalism. It is your responsibility to ensure that Miss Molalla Buckeroo activities take first priority. If you must be absent from an event or activity you are required to obtain the approval of the Court Committee five days in advance of the event or activity.
